Description:

The State Revenue Service (hereinafter - SRS) shall, upon receipt of the request for an EORI number, assign the EORI number to the person within 1-5 working days by establishing an EORI entry in the EORI system. A temporary number shall be assigned to natural persons registered in the Republic of Latvia for customs purposes in the Electronic Declaration System of the SRS in the Electronic Customs Data Processing System automatically, at the time of submission of the customs declaration.

Description:

The EORI number shall be assigned: • legal persons and individual merchants registered in the Republic of Latvia; • legal persons established outside the European Union; • natural persons carrying out business.

EORI Number (Economic Operators Registration and Identification number) - A business registration and identification number shall be a unique identification number in the customs territory of the Union, assigned by the customs authorities to an economic operator or other person for the purpose of registering it for customs purposes.

The EORI number assigned to the person concerned shall be used in all Member States of the European Union, irrespective of the Member State in which the EORI number was registered.

A person established in the customs territory of the Union may apply for an EORI number only in the Member State of the European Union where he is established.

A person established outside the customs territory of the Union (third-country person) may apply for an EORI number in the Member State of the European Union where it first carries out customs formalities.

Process description

Service requests

In order to obtain the EORI number, the EORI claim form shall be completed and signed:

- in the form of an electronic document (with a secure electronic signature) using the electronic mail address of the

Customs Office, EORI@vid.gov.lv, MP.lietvediba@vid.gov.lv or customs inspection post, or

- in the form of an electronic document in the Electronic Declaration System of the SRS (EDS); or
- in paper form at the Customs Office (see www.vid.gov.lv under “Contacts”) or Customs Control Point, or send by post to the Customs Office address of the State Revenue Service – Taleja Street 1, Riga, LV-1978.

A temporary number shall be assigned to natural persons established outside the European Union or in another Member State of the European Union.

The request for a provisional number shall be submitted in a free form:

- in the form of an electronic document (with a secure electronic signature), using the electronic mail address of the Customs Office, EORI@vid.gov.lv, MP.lietvediba@vid.gov.lv or customs inspection post, or
- in the form of paper in the presence of the Customs Office or the customs inspection post or by post to the address of the Customs Office - Taleja Street 1, Riga, LV-1978.

The temporary number of natural persons registered in the Republic of Latvia shall not be requested separately, it shall be granted automatically in the EDS Electronic Customs Data Processing System of the SRS at the time of submission of the customs declaration.
